 DMBC Grounds Maintenance Contract 2018/19. It appeared sites previously attended by DMBC had been omitted in the new contract It was agreed that DMBC should be contacted to discuss these areas.

 Both Councillors reported on the summer programme of activities within Conisbrough and Denaby as there had been a significant amount of anti - social behavior. The programme was aimed at teenagers with holding sports sessions, bike workshops and extending the opening hours of youth clubs.
 Within the Conisbrough Parks Parish area funding was being sought to provide signage and camera's to deter dumping. The Environment Agency had been contacted as in some areas toxic waste had been dumped. Cllr. Manning offered to meet officers during the Easter holiday to confirm the relevant dumping sites. This to be expedited by Cllr. Pearson.
 A response regarding the opening/closing times of the dumpit sites was still under review
 Carriageway repairs on Edlington 5 Lane Ends was still under investigation as the site was on the boundary of the Conisbrough / Edlington Warmsworth Wards.
